

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, MAY 1, 2019

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, May 1, 2019 in the Council Chambers of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board members: Lance Howard, Rick Rowland, Bill Sharp, Dave Spille, and Jim Johnson.

Also present: Hugh Skees, Attorney; Nancy Zeilman, CEB Secretary/City Clerk; Jeremy Kleier, Code Enforcement Administrator; Mike Macaluso, Code Enforcement Officer; Brian DeCarlo, Code Enforcement Officer; Kevin Vogelpohl, Fire Marshall; Ki Ransdale, Police Officer. In the audience: Ernest Hafley, contesting; Robert Bender, contesting; Aleta Beach, contesting; Christina Griffith, contesting; Melissa Ryzin, continued case.

APPROVAL OF MINUTES:

April 3, 2019

Chairman Johnson called for a motion to approve the minutes of the April 3, 2019 meeting of the Code Enforcement Board. Board member Sharp motioned to accept the minutes as read with a second from Board member Howard. **Motion carried by unanimous vote.**

ELECTION OF CODE ENFORCEMENT CHAIRMAN AND VICE CHAIRMAN

City Attorney Hugh Skees opened the floor for nominations to fill the 2019-2020 office of Chairman of the Code Board. Motion was made by Mr. Spille to nominate Jim Johnson as Chairman followed by a second from Mr. Rowland. **Motion carried by unanimous vote.**

Mr. Skees then opened the floor for nominations to fill the Vice Chairman position. Mr. Spille nominated Bill Sharp followed by a second from Mr. Howard. **Motion carried by unanimous vote.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASE:

Contested Case #2019-132-PM 31 Kentaboo Ave

City of Florence vs. Aleta Beach MM-2019-161

Officer Macaluso presented the case as follows: 1/19 tarps on roof, 1/11 Letter sent, 2/4 phone call stating roof needed to be replaced, 2/28 no change, 4/11 no change. Officer Macaluso issued the first citation, 4/29 roof still had tarp.

Ms. Beach appeared and testified as follows: The roof sustained hail and storm damage. Her insurance company made 3 visits and stated to her that it would be covered. A fourth visit from the insurance company denied her claim. She stated her children will replace the roof but they need to wait for better weather. Mr. Spille motioned to continue the case for 60 days (July hearing) to allow the family to make the repairs. Mr. Rowland followed with a second.

Contested Case #2018-450-PM/ZG 104 Lloyd Avenue Being contested by Robert Bender City of Florence vs Laura Linton Multiple Citations

Mr. Bender was on the agenda to appear at the April Hearing but could not make it so all citations were upheld. He spoke with Nancy Zeilman the afternoon that he was to appear and ask if he could contest in May. The Code Officer gave his approval. Mr. Howard motioned to re-open the case with a second from Mr. Sharp. **Motion was carried by unanimous vote.**

Officer Macaluso presented the case as follows: 6/26/18 sent letter for violations. 7/18 no change. He spoke with the tenant in the house who ask Officer Macaluso to leave. 8/7 no change, 8/14 no change, 8/16, no change issued 2nd citation, 8/31 3rd citation, 10/15 4th citation and issued a new citation for trash/debris. 10/25 no change on original citation so issued 5th citation, 11/6 6th citation, 11/15 7th citation, 11/27 8th citation, 12/4 9th citation, 12/11 10th citation. On 2/14, Officer Macaluso noticed a pallet of roofing material on the property. After speaking with Mr. Bender on April 1st, Officer Macaluso inspected the property on 3/7/19. Almost all violations were now in code. 3/12 Mr. Bender notified Officer Macaluso that he is trying to sell the property. Inspection today showed that the property is now in compliance. Total amount owed is \$13,790.62. City incurred expenses total \$502.62.

Mr. Bender stated that he and his wife live in Florida and his stepson, who was living in the house, was not forwarding the citations. He is now evicted. Mr. Bender was not aware of the state of the property until he started receiving notices about liens being filed.

Mr. Sharp motioned to dismiss all fines except the \$502.62 which the city is owed. Mr. Howard followed with a second. Motion was carried by unanimous vote.

Mr. Bender was informed that after he pays the \$502.62, all liens will be released.

Contested Case #2019-92-OC 8544 US 42

City of Florence vs Iron Rig Fitness Mike Macaluso

This case is being contested by Joseph Stotlar. Mr. Stotlar call the City Clerk before the hearing stating that he could not attend but would ask if he could contest in June.

Motion made by Mr. Spille to continue the case to the June hearing followed by a second from Mr. Howard. The motion carried by unanimous vote.

Contested Case #2019-63-OC 60 Cavalier

City of Florence vs. Ernest Hafley Mike Macaluso

Officer Macaluso presented the case as follows: Mr. Hafley received a letter for no Occupational License on 1/4/19. 2/12 no change 1st citation, 2/18 Ask for extension, 2/25 one week extension from finance, 3 / 4 no changed issued 2nd citation, 3/18 no change 3rd citation left at front desk of business, 3/19 Mr. Hafley called. He explained that there was a mix up in finance with his applications from past years.

Mr. Hafley appeared and stated that he was eventually told by finance that he owed \$96.00. He found his cancelled check and showed it to finance. Finance had applied it to 2015 instead of 2016. He said he thought everything was fine then they told him he owed 2018.

Mr. Hafley is now in compliance and requested that the fines be waived. Mr. Spille motioned that the case be dismissed. Mr. Sharp followed with a second. **Motion carried by unanimous vote**.

Contested Case #2019-114-PM 11 Morris Street

City of Florence vs. Susan Bennett Mike Macaluso

Ms. Bennett did not appear at the hearing. Officer Macaluso presented the case and explained that she is now in compliance. Motion made by Mr. Howard to dismiss the fine with a second from Mr. Sharp. Motion carried by unanimous vote.

Contested Case #2019-125-PM 8400 US 42

City of Florence vs. Christine Griffith Mike Macaluso

Officer Macaluso presented the case as follows: 2/8 sent a letter to Ms. Griffith concerning potholes in parking lot. 3/14 no change, 1st citation. Gave to tenants, 4/1 no change, 2nd citation, 4/8 no change, 3rd citation 4/14, call from Ms. Griffith stating she will have the potholes fixed. Inspection on April 29 showed that she is now in compliance.

Ms. Griffith appeared and requested the fines be reduced or dismissed. Mr. Howard motioned to dismiss the case with a second from Mr. Sharp. **Motion carried by unanimous vote.**

Contested Case # 2019-104-PM 8400 US 42

City of Florence vs Christine Griffith Brian DeCarlo

Officer DeCarlo presented the case as follows: 2/12 he noticed a free standing sign in disrepair. 2/19 sent a letter, 3/22 1st citation for sign with holes, 4/12 Brian spoke with her about multiple violations. 4/27 no change, 4/29 no change. The sign is missing a panel.

Ms. Griffith appeared and stated that she had contacted a few sign companies to help with the repair but was not receiving answers. Boardmember Spille recommended that she call Quality Signs. Mr Howard motioned that the case be continued until June to allow Ms. Griffith to repair the sign. Mr. Sharp followed with a second. **Motion carried by unanimous vote.**

City of Florence vs Willow Acupressure Mike Macaluso

There was no representative from Willow Acupressure in the audience. Mr. Rowland motioned to uphold the citation followed by a second from Mr. Sharp. **Motion carried by unanimous vote.**
