MINUTES – BUSINESS MEETING

TUESDAY, JANUARY 22, 2019

The City Council of the City of Florence, Kentucky met in Regular Session on Tuesday, January 22, 2019 at 6:30 p.m. in the Florence Government Center, with Mayor Diane E. Whalen presiding as Chair.

CALL TO ORDER & WELCOME:

Mayor Diane E. Whalen called the regular meeting to order and declared the Regular Session to be open for the presentation of all City business.

APPROVAL OF MINUTES:

JANUARY 5, 2019 - SPECIAL MEETING

Mayor Whalen called for a motion to approve the minutes of the January 5, 2019 Special Meeting. Council Member Winn so moved with a second from Council Member Huff. Council Approved by Unanimous Vote.

SECOND READING ORDINANCE NO. O-11-18

AN ORDINANCE ANNEXING CERTAIN TERRITORY CONSISTING OF A PARCEL OF APPROXIMATLEY 14.86 ACRES LOCATED ON THE EAST SIDE OF GUNPOWDER ROAD, SOUTH OF U.S.42, ADJACENT TO THE CITY LIMITS. (SCHRODER/DRYDEN/INSKEEP PROPERTY).

Mayor Whalen called for a motion to approve Ordinance No. O-11-18. Council Member Huff motioned with a second from Council Member Aubuchon. Council Approved by Unanimous Vote.

SECOND READING ORDINANCE NO. O-1-19

AN ORDINANCE ADOPTING AND APPROVING A ZONING MAP AMENDMENT FROM SUBURBAN RESIDENTIAL ONE (SR-1) TO PUBLIC FACILITIES (PF) FOR A 14.86 ACRE SITE LOCATED ON THE EAST SIDE OF GUNPOWDER ROAD, SOUTH OF U.S. 42, ADJACENT TO THE CITY LIMITS, TO ALLOW A MEMORY CARE, ASSISTED LIVING AND SENIOR HOUSING, (BERLING/DRYDEN PROPERTY)

Mayor Whalen explained that City Council has taken the first reading of an Annexation of the property. Following the second reading of the Zoning Map Amendment, Council will take 2nd reading of the Annexation as well.

Mayor Whalen called for a motion to approve Ordinance No. O-1-19. Council Member Winn motioned with a second from Council Member Huff. Council Approved by Unanimous Vote.

FIRST READING ORDINANCE O-2-19

AN ORDINANCE OF THE CITY OF FLORENCE, KENTUCKY, AMENDING THE BUDGET FOR THE 2018-2019 FISCAL YEAR OF THE CITY. (AMENDMENT #1)

Mayor Whalen called for a motion to approve first reading of O-2-19. Council Member Osborne motioned with a second from Council Member Froelicher. **Council Approved by Unanimous Vote.**

FIRST READING ORDINANCE O-3-19

AN ORDINANCE RELATING TO PERSONNEL; AMEDING ORDINANCE NO. O-8-18 RELATING TO PERSONNEL POLICIES, JOB DESCRIPTIONS, ATHORIZED POSITIONS AND THE PAY PLAN.

Mayor Whalen called for a motion to approve first reading of O-3-19. Council Member Aubuchon motioned with a second from Council Member Froelicher. Council Approved by Unanimous Vote.

FIRST READING ORDINANCE 0-4-19

AN ORDINANCE RELATING TO FEES AND CHARGES TO BE PAID BY USERS OF THE CITY WATERWORKS SYSTEM, SANITARY SEWER SYSTEM, AND STORM SEWER SYSTEM.
