### MINUTES – BUSINESS MEETING

**TUESDAY, JANUARY 8, 2019** 

The City Council of the City of Florence, Kentucky met in Regular Session on Tuesday, January 8, 2019 at 6:30 p.m. in the Florence Government Center, with Mayor Diane E. Whalen presiding as Chair.

## **CALL TO ORDER & WELCOME:**

Mayor Diane E. Whalen called the regular meeting to order and declared the Regular Session to be open for the presentation of all City business.
