

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, NOVEMBER 4, 2020

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, November 4, 2020 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

Chairman Johnson called the meeting to order and requested a roll call. Present were the following four (4) Board members: Lance Howard, Rick Rowland, Bill Sharp, and Jim Johnson. Board Member David Spille was absent.

Also present: Hugh O. Skees, Attorney; Brandi Roundtree, Assistant City Clerk; Mike Macaluso, Code Enforcement Officer; Brian DeCarlo, Code Enforcement Officer; David Rose, Code Enforcement Officer; Rodney Deno, Code Enforcement Officer; Randy Childress, Fire Marshall; Kevin Duncan, Police Officer. In the audience: Steven Young, contesting; James Claxton, contesting; Charles Ritter, continued case; Debra Garijo-Gillon, continued case; and Bob Hahn, continued case.

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the October 7, 2020 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (2):

Contested Case #2020-354-PM 67 Stonegate Drive

City of Florence vs. Steven Young Multiple Citations

Officer DeCarlo presented the case as follows: Mr. Kleier began citing Mr. Young for violations in April of 2018. Mr. Young indicated he had been doing several improvements in order to sell the property, including eaves and gutters on the detached garage. 1/11/19, Officer DeCarlo observed the eaves and soffits on the detached garage were in need of paint, sent letter. 1/24/19 Officer DeCarlo received voicemail from Mr. Young; 1/28 returned call unable to leave message. 2/11/19 Officer DeCarlo received another voicemail from Mr. Young stating surgery and bad weather halted work until March. Officer DeCarlo gave Mr. Young until the end of March to get work completed. 4/3/19 new siding and paint on the house, no change to garage. 6/13/19 Officer DeCarlo spoke to Mr. Young on site, Mr. Young stated he was having new siding, roof, new driveway and steps installed, then work on the garage would begin. 7/16/19 work ongoing and some progress; 8/19/19 1st citation issued for siding missing and holes in eaves and soffits on detached garage; 9/19/19- no change; 11/19/19 siding on house fixed, no change to garage. 3/19/20 Mr. Kleier also observed the detached garage unresolved, on hold at that time due to COVID-19. 6/23/2020 sent notice after enforcement began for trim missing, holes in eaves and soffits on the detached garage. 8/3/20, 2nd notice sent for same violations; 9/9/20, trim missing and no change to the garage; 2nd citation issued on 10/13/20; 11/4/20 inspection completed, siding missing and soffits and eaves still not in compliance.

Steven Young appeared and stated he built the detached garage himself, and a year later it caught fire. The insurance company did not insure the garage because it was not attached to the house; therefore, he had to replace the garage at his own cost. It is almost complete with the exception of the eaves, soffits, and gutter boards. In the meantime they had storm damage to the house which required new siding and new roof. Repairs on the garage had to be halted in favor of the house repairs due to water damage occurring in the house. The materials for the detached garage were ordered on 9/3/20 from ABC Roofing Supply. Mr. Young received a delivery date of 11/13/20 for the materials needed to repair the garage. Mr. Young stated that all repairs would be completed within a week of receiving materials.

Mr. Sharp inquired about citations from April of 2018 regarding the fence around the pool. Officer DeCarlo stated that those citations were closed out by Mr. Kleier. However, Officer DeCarlo stated that a new notice was sent out for the pool fence on 11/2/20. Mr. Young stated that he has ordered the materials to fix the pool fence also.

Mr. Howard motioned to continue the case until the December 2, 2020 hearing. Mr. Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case #2020-146-NU 7920 Dream Street Contested by James Claxton City of Florence vs. Claxton Properties Citation # BD-2020-67

Officer DeCarlo presented the case as follows: Sent first notice for high grass and weeds on 4/20/20; 4/27/20 no change, 1st citation issued. Mr. Claxton called Mr. DeCarlo the same day stating that his landscaper was recovering from COVID-19 and that he was trying to find someone else to fix the issues. Officer DeCarlo informed Mr. Claxton that as long as the issue was fixed by the next inspection, Officer DeCarlo would ask the board to dismiss the citation. Officer DeCarlo completed 2 more inspections over the next month before the citation was corrected.

James Claxton appeared on behalf of Claxton Properties and stated that the reason it took so long to get the grass taken care of was due to COVID-19 and he requested that the board dismiss his fines.

Mr. Howard motioned to dismiss the citation. Mr. Rowland followed with a second. **Motion carried by unanimous vote**.
