BEGINNING at an existing cross notch in the northwest right-of-way line of Main Street, at the most easterly corner of Mary Rose Mission, Inc. (Deed Book 1005, page 156) and in the southeast right-ofway line of said alley;

THENCE leaving the right-of-way line of Main Street and with the southwest right-of-way line of said alley and Mary Rose Mission, Inc. N 50°52'27" W a distance of 127.66 feet to an existing Mag nail at the most northerly common corner of said alley and Mary Rose Mission, Inc.;


