

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, APRIL 6, 2022

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, April 6, 2022 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board members: David Spille, Lance Howard, Rick Rowland, Bill Sharp, and Jim Johnson.

Also present: Thomas Nienaber, Assistant City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Jacob Carpenter, Code Enforcement Officer; Rodney Deno, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Childress, Fire Marshal; and Kevin Duncan, Police Officer.

In the audience: Jesse Shipp, contested case; Steven Gaspard, contested case; Greg Cervenka, Attorney for Florence DG, LLC, contested case; Steve Young, contested case; Jeanelle Phillips, contested case; and Craymon Maples, continued case.

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the March 2, 2022 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (8):

Contested Case # 2021-65-OC 100 Lee Street Contested by: Jesse Shipp City of Florence vs. Love My Home, LLC Multiple Citations

Officer Macaluso presented the case as follows: Case was initiated on 6/9/21 regarding a rental property. Owners were cited for not being in compliance with the City of Florence Occupational License. Seven (7) citations were issued. Payment of \$50.00 was received with a balance due of \$1,650. Property owners are now in compliance. Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-54-ZG 7095 Manderlay Drive City of Florence vs. Amanda (Kennedy) Brown Citation # 22-66-1

Officer Deno presented the case as follows: Ms. Brown is a nurse and was unable to attend the meeting due to work obligations. Officer Deno requested a continuance to the May 4, 2022 meeting. Board Member Spille motioned to continue the case to the May 4, 2022 meeting. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2021-161-ZG 4800 Houston Road Contested by: AJ Crank City of Florence vs. Cole Lo Florence KY Multiple Citations

Officer Macaluso presented the case as follows: No one appeared on behalf of Cole Lo Florence KY LLC. Officer Macaluso stated the property is not in compliance and requested the board uphold the citations. Board Member Rowland motioned to uphold all citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2020-397-ZG 7641 Dixie Highway Contested by: Greg Cervenka, Attorney City of Florence vs. Florence DG LLC Multiple Citations

Officer Macaluso presented the case as follows: Case was initiated 6/24/2020 for landscaping, sidewalk/driveway conditions, and striping. The sidewalk/driveway conditions and striping repairs have been completed. The landscaping remains not in compliance. Approximately 200 pieces of landscaping items are missing. Nine citations have been issued, with seven liens filed. All citation and lien fees have been paid in full.

Board Member Howard inquired if the landscaping that is missing is required through the site plan. Officer Macaluso confirmed the missing landscaping is required by the site plan. Officer Macaluso stated the property owners have been informed a new site plan can be filed to alter the landscaping requirements which would bring the property into compliance.

Greg Cervenka, attorney and partial owner, appeared on behalf of Florence DG LLC. Mr. Cervenka stated the property was built by previous owners. His company acquired the property in 2020. Mr. Cervenka stated fifty of the bushes required on the site plan would be in a drainage ditch and would not tolerate the drainage. The property included in the original site plan has been divided and owned by two separate property owners. Some of the required landscaping on the current site plan is no longer owned by Florence DG, LLC. Chairman Johnson informed Mr. Cervenka he will need to have a new site plan submitted due to the violations as stated.

Board Member Spille informed Mr. Cervenka a revised site plan can be submitted to the Boone County Planning and Zoning. Officer Macaluso inquired if Mr. Cervenka has his contact information. Mr. Cervenka confirmed, they have emailed in the past and that is when he contacted the City Attorney, Mr. Skees. Officer Macaluso advised Mr. Cervenka to email him and Officer Macaluso would provide the contact information for the Boone County Planning and Zoning.

Board Member Howard requested the case be continued 90 days. Board Member Sharp seconded the motion. **Motion** carried by unanimous vote.

Contested Case # 2022-78-NU 7 Lynn Street

City of Florence vs. Carlos Higareda Citation # 22-371-1

Officer Deno presented the case as follows: Received a resident complaint regarding the property. 2/22 an inspection was completed and observed trash and debris at the property due a house fire. After the citation was issued, property owner contacted Officer Deno and informed him the claims adjuster had instructed him to not move anything, as they were still inspecting the damage to the property. Three days later, the contractor informed Officer Deno that the property was being cleaned up and repairs were being completed. The property is currently in compliance. Board Member Howard motioned to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-22-PC 8378 Cypress Lane

City of Florence vs. Steven Gaspard Police Citation # 111

Police Officer Duncan presented the case as follows: On 3/14/22 Police Officer Patrick Cottingham observed a Ford Fusion parked in the cul-de-sac located on Cypress Lane. Violation was listed as "no parking in circle."

Steven Gaspard appeared and stated he had parked his vehicle in the circle temporarily while he was unloading heavy items from a truck parked in his driveway. He resides at 8378 Cypress Lane. He was unable to park at the bottom of his driveway due to children playing in the area.

Board Member Spille stated the sign posted states no parking in circle and motioned to uphold the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2021-150-OC 6805 Houston Road, Suite 200 Contested by: Jeanelle Phillips

City of Florence vs. Burben Investments/Sports Clips Multiple Citations

Officer Macaluso presented the case as follows: Occupational License Violation, case was initiated on 8/30/2021 with six citations being issued. Officer Macaluso spoke with Ms. Phillips on 3/24/22 regarding citations. Property is now in compliance.

Jeanelle Phillips, Business Manager, appeared on behalf of Sports Clips. Ms. Phillips stated when she learned of the initial citation in September of 2021, she contacted the city and was informed the issue was withholding tax on the payroll for the employees. Ms. Phillips contacted the payroll company regarding the issue with the withholding and to address the back taxes. The payroll company informed her the issue would take two months to be resolved. Ms. Phillips contacted the city and was informed as long as they kept in contact regarding the progress, it would be fine. Citations continued to be issued. In January, the owner issued a personal check to the city to bring the business into compliance. In February, she was notified that the business was not in compliance. Ms. Phillips called the city back and was informed the payroll company had issued a check and the occupational license was in compliance. Ms. Phillips stated an additional citation was issued in March and she contacted Officer Macaluso. Following their conversation, she was informed to attend the Code Enforcement Board meeting.

Board Member Howard requested confirmation that the company is currently in compliance. Officer Macaluso confirmed. Board Member Howard motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-53-PM 67 Stonegate Drive Contested by: Steven Young City of Florence vs. Steven & Rose Young Citation # 20-435-5

Officer Carpenter presented the case as follows: Citation was issued for swimming pool condition and accessory structure condition of the deck. Spoke with Mr. Young on site this morning. Upon inspection, the cover was on the swimming pool but not securely tightened. The deck was actively being worked on. Officer Carpenter further noted the staircase on the deck also needed a handrail. The property is not in compliance.

Steve Young appeared and stated the deck rails are now completed and the posts for the staircase are currently being installed. To address the pool issue, Mr. Young intends to install 2x4s across the pool cover to keep the cover from coming loose. Furthermore, he purchased a pump to keep water from accumulating on the pool cover. The pool plaster is scheduled to ship on May 15, and he will be able to properly complete the pool repairs at that time.

Board Member Howard asked Officer Carpenter when the inspection was completed. Officer Carpenter stated the inspection occurred morning. Board Member Howard inquired of Mr. Young when he started the repairs. Mr. Young stated the railing installation began three days ago. Mr. Young further stated he ordered the wire for the hand rails two weeks ago and he received on Monday.

Board Member Spille addressed Mr. Young as to the ongoing violations and repairs. Board Member Spille encouraged Mr. Young to communicate with the code officer as to the ongoing repairs and challenges he has undergone the past two years. Board Member Spille motioned to uphold the citation. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Mr. Maples requested additional time to come into compliance. Board Member Spille motioned to continue the case sixty days. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

ATTORNEY'S REPORT:

Attorney Nienaber stated the owner of Pine Lake Apartments is actively working on repairs. Bryce Rhodes is no longer representing the city and the new attorney is Mary Ann Stewart. Negotiations regarding the Settlement Agreement are ongoing.

ADJOURNMENT:

Chairman Johnson reminded the Board the next meeting will be held on May 4, 2022.

There being no further business to come before the Board, Chairman Johnson called for a motion to adjourn. Board Member Howard so moved, with a second from Board Member Sharp. **Motion passed with unanimous approval of the Board**, the time being 10:40 a.m.
