

Florence City Council Business Meeting Tuesday, May 10, 2022 6:00 p.m.

MINUTES

The City Council of the City of Florence, Kentucky, met in regular session on Tuesday, May 10, 2022 at 6:00 p.m. at the Florence Government Center, 8100 Ewing Boulevard, Florence, Kentucky, with Mayor Diane E. Whalen presiding as chair.

CALL TO ORDER & WELCOME:

Mayor Diane E. Whalen called the regular meeting to order and declared the regular session open for the presentation of all city business.

ROLL CALL:

The roll was called, and the following five (5) members of council were registered present: Mel Carroll, J. Kelly Huff, David Osborne, Patricia Wingo, and Gary Winn. Councilmember Dr. Julie Aubuchon was absent.

Staff members present were: Assistant City Attorney, Dale T. APPROVAL OF MINUTES:

Mayor Whalen called for a motion to approve the minutes of the April 26, 2022, business meeting. Councilmember Winn motioned to approve the minutes with a second from Councilmember Wingo. All councilmembers present voted aye.

PRESENTATION – ST. ELIZABETH HEALTHCARE:

Mayor Whalen introduced and welcomed Bruno Giacomuzzi, Chief Operating Officer at the Florence/Grant facilities.

On behalf of St. Elizabeth Healthcare, Mr. Giacomuzzi wanted to provide an update on the redevelopment of the St. Elizabeth Healthcare Florence Campus. As part of the redevelopment, Mr. Giacomuzzi stated St. Elizabeth Healthcare is relocating and consolidating their inpatient orthopeadic services and endoscopy from the Edgewood campus to the Florence campus. The project includes renovating ten existing operating rooms, creating five new operating rooms, and a total reconfiguration and expansion of the Pre/Post and Post Anesthesia Care Unit (PACU) areas to support the growth of general surgery and Bariatric Surgery. St. Elizabeth Healthcare is recognized as a Blue Center of Excellence in Bariatric Surgery. In addition, they will be reconfiguring the campus roadways for a more natural flow of traffic on campus. The project will also include renovation and reconfiguration of 24,000 square feet of inpatient space.

Mr. Giacomuzzi identified architectural renderings and the new view of the hospital from Houston Road with renderings of the new main entrance and lobby/reception area. Mr. Giacomuzzi identified additional renderings of the concourse to the hospital patient rooms, main entrance view to the concourse and entrance to physical therapy. Exterior work to the hospital including parking and the reconstruction of Ring Road was identified. New building additions including the St. Elizabeth Physicians Endoscopy building and the spine facility were shown. Additional renderings of the interior work including the sterile supply processing department, nursing room renovations, new inpatient spine unit, and significant upgrades to the infrastructure and renovations to the patient rooms were shown. Renovations to the Post Anesthesia Care Unit /Operating Rooms expansion, administration, conference, inpatient physical therapy, orthopaedic education, and addition of the third floor were identified. As a result of the increase in staff and services at the Florence location, Mr. Giacomuzzi stated expansions will occur to the physicians lounge, support areas, and cafeteria seating. All of the renovations are anticipated to be completed by the end of 2023.

Councilmember Osborne inquired with regard to how many employees the Florence campus will need to accommodate the additions. Mr. Giacomuzzi stated some of the employees will relocate from the Edgewood campus to the Florence campus. Currently there are approximately one thousand employees on the campus daily and an increase of two hundred employees could occur.

Councilmember Carroll believes St. Elizabeth Florence to be a "crown jewel" of the community. He stated the upgrades and additions were very welcomed and appreciated.

Mr. Giacomuzzi was appreciative of the help and support received by the city. Mayor Whalen thanked Mr. Giacomuzzi for attending the meeting and for providing an update on the redevelopment.

An Ordinance adopting and approving a change in a Concept Development Plan in a Commercial Two / Planned Development / Mall Road Overlay (C-2/PD/MR) District for an approximate 11.5 acre site located at 828 Heights Boulevard, Florence, Kentucky, to allow alternative building colors. (Crossroads Community Church, Inc.)

The effect of this Ordinance is to allow alternative building colors in a Commercial Two/Planned Development/Mall Road Overlay (C-2/PD/MR) District.

- Mayor Whalen informed everyone the Kentucky Driver Licensing Regional Office has opened a second location in Northern Kentucky. The new location is at 1840 Simon Kenton Way, Covington. The Burlington location is located at 6159 First Financial Drive. At either location you may obtain standard and REAL ID license, permits and ID cards. Mayor Whalen recommended scheduling an appointment online.
- Mayor Whalen reminded everyone the Florence Aquatic Center will open May 28 and hours of operation will be 11:00 a.m. to 7:00 p.m.
- Mayor Whalen announced city offices will be closed on Monday, May 30 in observance of Memorial Day.
- Mayor Whalen stated the Memorial Day Parade will be held Monday, May 30. The parade will begin at Boone County High School at 10:00 a.m. and will end at the Florence Government Center. Following the parade, the Memorial Day Ceremony will be held at the Veterans Memorial located at the Florence Government Center.
- Mayor Whalen informed everyone former Boone County Court Judge, Robert F. Greene passed away. She offered her condolences to the family.
