

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, OCTOBER 5, 2022

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, October 5, 2022 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board members: Jim Johnson, Chairman; Rick Rowland, (Vice-Chairman); David Spille; Lance Howard; and Bill Sharp.

Also present: Thomas Nienaber, Assistant City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Jacob Carpenter, Code Enforcement Officer; Rodney Deno, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Childress, Fire Marshal; and Ki Ransdall, Police Officer.

In the audience: Ousmane Kounta, contested case; Dale Bertram, contested case; Keith Wimsatt, contested case; Andrew Buter, contested case; William Mitchell, contested case; Karla Magallan, contested case; Johnny Eggleston, continued case; and Mary Jo Jones, continued case.

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the September 7, 2022 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. Chairman Johnson was absent from the September 7, 2022 meeting and abstained from the vote. **The Board approved 4-0 with abstention from Chairman Johnson.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (6):

Contested Case # 2022-22-OC/ZG 7503 Industrial Road

Contested by: Ousmane Kounta

City of Florence vs. MABEF, LLC

Multiple Citations

Officer Deno presented the case as follows: Inspection completed on 4/27, observed high grass and weeds; trash and debris; and watercourse debris, courtesy notice sent. Follow up inspection completed on 5/17, no change, issued citation. Second citation issued 6/21. Officer Deno met property owners onsite regarding open violations. All violations for this case are in compliance.

Officer Macaluso presented his case as follows: Case began on 12/28/21, Officer Macaluso observed sign permit violation, temporary advertisement display on the outside of the building, and occupational license violation. Three citations have been issued. Currently, the sign has been placed on the inside of the door and temporary advertising display has been removed. However, the U-Haul business located on the left side of the building does not have an occupational license. The property is not in compliance.

Ousmane Kounta appeared on behalf of MABEF, LLC and stated he hired a contractor to repair all violations and the property is now in compliance.

Chairman Johnson stated all violations are in compliance with the exception of the occupational license. Mr. Kounta stated he was unable to obtain the occupational license without filing his tax returns. He filed for an extension. He has applied for the occupational license and is awaiting on a reply from the city. Mr. Kounta provided a receipt for his occupational license. Officer Macaluso informed Mr. Kounta the receipt he provided is for a renewal of an occupational license for the daycare located on the property. Officer Macaluso informed Mr. Kounta he is required to have a separate

occupational license for the U-Haul business. Mr. Kounta stated the U-Haul business has been evicted and has been given 30 days to vacate the property. Officer Macaluso stated the issue is the business is still operating without a business license.

Mr. Kounta stated he was under the impression the U-Haul business was permitted to be at the location as long as there are no U-Haul trucks stored at the property. Office Macaluso confirmed the office is permitted in the building; however, an occupational license is still required.

Board Member Howard asked Mr. Kounta if he is collecting rent from the owner of the U-Haul business. Mr. Kounta stated he is receiving a commission from the business.

Board Member Spille made a motion to continue the case 30 days. Board Member Sharp seconded the motion. **Motion carried by unanimous vote.**

Contested Case # 2021-206-OC 7220 Burlington Pike Contested by: Karla Magallan City of Florence vs. Healthy Hangout Multiple Citations

Officer Macaluso presented the case as follows: Case initiated on 7/23/21, eight citations have been issued. There was confusion regarding the businesses at the property. Officer Macaluso was under the impression there is a singular business at the location; however, there is another business also located at that property address. All citations being contested were issued to Healthy Hangout. Property is currently in compliance.

Karla Magallan appeared on behalf of Healthy Hangout and stated the other business located at that property address is Chill Spa Nutrition. Officer Macaluso confirmed the city is actively pursuing enforcement against Chill Spa Nutrition.

Board Member Spille motioned to dismiss the citations. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-137-OC 51 Grand Ave.

City of Florence vs. Keith Wimsatt Multiple Citations

Officer Macaluso presented the case as follows: Property owner of 51 Grand Avenue is operating a painting company out of his house. Case was opened on 4/13/21 and three citations have been issued. Officer Macaluso spoke with Mr. Wimsatt and instructed him to contact the Finance Department to bring the business into compliance. Mr. Wimsatt has completed all requirements and the business is currently in compliance.

Board Member Spille motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-314-NU/ZG 65 Vivian Drive Contested by: Dale Bertram City of Florence vs. Mary Bertram Citation # 22-1721-1

Officer Carpenter presented the case as follows: Case was opened on 8/26 for RV/trailer storage and trash and debris, courtesy notice sent. Citation was issued on 9/6. Property is currently in compliance. Office Carpenter noted the courtesy notice was returned on 9/20. Therefore, it is unlikely the property owners knew of the violation before the citation was issued.

Dale Bertram stated he did not receive the courtesy notice and did not know the property was in violation until the citation was posted on the premises. At that time, the violations were corrected and the property was brought into compliance.

Board Member Spille motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2021-285-MU 21 Lakeshore Drive Contested by: Andrew Buter

City of Florence vs. Rex Residential Property Owner A, LLC Multiple Citations

Officer Carpenter presented the case as follows: Case was initiated on 4/28, for roof and drainage; high weeds; trash and debris; unlicensed/disabled vehicle; and landscaping conditions. Nineteen citations totaling \$7,450 have been issued with an additional city expense in the amount of \$1,060 being owed. Property is currently in compliance.

Officer Carpenter noted when the case was opened, the mailing address was a South Carolina address; however, recently the mailing address was updated to Dayton, Ohio.

Andrew Buter appeared on behalf of Rex Residential Property Owner A, LLC and stated the property is a rental property recently purchased by his employer. The tenant is no longer residing at the property and all repairs have been completed.

Board Member Spille motioned to dismiss the citations and uphold the city expense in the amount of \$1,060. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2021-126-OC 71 Cavalier Blvd. Contested by: William Mitchell

City of Florence vs. Wealth Wave Multiple Citations

Officer Macaluso presented the case as follows: Case was not on the agenda; however, case will be heard due to Mr. Mitchell appearing. Case created on 8/9/21 with six citations being issued for Occupational License violations. Property is currently in compliance.

Board Member Howard motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**
