# CITY OF FLORENCE, KENTUCKY ORDINANCE 0-23-22

AN ORDINANCE TO UPDATE THE TRAFFIC REGULATIONS OF THE CITY BY AMENDING ORDINANCE NO. 0-21-19 RELATING TO PARKING PROHIBITIONS, STOP SIGNS, SPEED REGULATIONS, TRUCK TRAFFIC PROHIBITIONS, LEFT TURN PROHIBITIONS, ONE-WAY STREETS; AND RIGHT TURN ONLY STREETS.

**WHEREAS**, the City Council of the City of Florence, Kentucky, has determined that the health, welfare, and best interest of the citizens and persons using the streets of the City of Florence, Kentucky, require that the following traffic regulation revisions be made.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FLORENCE, KENTUCKY, AS FOLLOWS:

### **SECTION I - PARKING PROHIBITIONS**

That Section One of Ordinance No. O-21-19 is hereby amended as follows:

It shall be a violation for any person, firm or corporation to part or permit to be parked or to leave standing any automobile, truck, bus or other vehicle operated or owned by them or under their control in any of the locations designated in Exhibit "A" - which is attached hereto and incorporated herein. At such locations, the parking prohibition covers not only the traveled portion of that side of the street referred to, but specifically extends to the limit of the right-of-way for each street.

#### **SECTION II - STOP SIGNS**

That Section Two of Ordinance No O-21-19 is hereby amended as set out in Exhibit "B" which is attached hereto and incorporated herein.

#### **SECTION III - SPEED LIMITS**

That Section Three of Ordinance No. O-21-19 is hereby amended as set out in Exhibit "C" which is attached hereto and incorporated herein.

# SECTION IV - TRUCK TRAFFIC PROHIBITED

That Section Four of Ordinance No. O-21-19 is hereby amended as set out in Exhibit "D" which is attached hereto and incorporated herein.

#### **SECTION V - LEFT TURNS PROHIBITED**

That Section Five of Ordinance No. O-21-19 is hereby amended as set out in Exhibit "E"

which is attached hereto and incorporated herein.

#### **SECTION VI - ONE-WAY STREETS**

That Section Six of Ordinance No. O-21-19 is hereby amended to read as follows:

The portion of the streets as listed on Exhibit "F" - which is attached hereto and incorporated herein, are designated as one-way streets and hereafter vehicular traffic shall be permitted to proceed only in the directions indicated.

# **SECTION VII - RIGHT TURN ONLY PERMITTED**

That Section Seven of Ordinance No. O-21-19 is hereby amended to read as follows:

It shall be unlawful for the operator of any vehicle to make a left-hand turn or proceed across the areas designated as set out in Exhibit "G" which is attached hereto and incorporated herein and operators may be permitted to make a right-turn only in the indicated directions.

# **SECTION VIII**

All of the remaining Sections of Ordinance No. O-21-19 amended by this Ordinance, not in conflict with the provisions hereof, shall remain in full force and effect.

# **SECTION IX**

This Ordinance shall be published by posting on the City's internet website.
