

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, MARCH 1, 2023

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, March 1, 2023 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board members: Jim Johnson, Chairman; Rick Rowland, (Vice-Chairman); David Spille; Lance Howard; and Bill Sharp.

Also present: Thomas Nienaber, Assistant City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Rodney Deno, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Childress, Fire Marshal; and Chris Billiter, Police Sergeant.

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the February 1, 2023 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (9):

Contested Case # 2022-101-OC 7107-7129 Turfway Road Contested by: Annushree Patel

City of Florence vs. Harihar LLC dba Subway Multiple Citations

Officer Macaluso presented the case as follows: 1/12/22 received notification from the Finance Department that the occupational license was not in compliance, courtesy notice sent. First Citation issued on 1/31/22, with six additional citations were issued. The last citation was issued on 2/7/23. Occupational license is currently in compliance.

Annushree Patel appeared on behalf of Harihar LLC dba Subway.

Board Member Rowland motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case #2022-716-OC 7210 Turfway Road

City of Florence vs. Michael Constantino Multiple Citations

Officer Macaluso presented the case as follows: 8/9/22 received notification from the Finance Department that the occupational license was not in compliance, courtesy notice sent. First citation was issued on 10/8/22 and second citation was issued on 2/7/23. Occupational license is not in compliance.

Michael Constantino appeared and stated he is a new real estate agent and was unaware that an occupational license was required in the City of Florence. Mr. Constantino paid the first citation to the Finance Department and thought the issue was

resolved. He was not aware an occupational license was required and that additional citations would be issued. Mr. Constantino stated he would be able to bring the occupational license into compliance by the next meeting.

Board Member Spille made a motion to continue the case to the April meeting with the stipulation that if the occupational license is in compliance, Mr. Constantino does not need to appear at the April meeting. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-147-OC 60 Cavalier Blvd.

City of Florence vs. Donna Berling Citation # 21-2606-1

Officer Macaluso presented the case as follows: 9/15/22 received notification from the Finance Department that the occupational license was not in compliance, courtesy notice sent. First citation issued on 1/19/23. Occupational license is currently in compliance.

Board Member Howard motioned to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2020-82-PM/ZG 132-135 Honeysuckle Drive Contested by: Robert Busken City of Florence vs. Tower Place Properties, LLC Multiple Citations

Officer Macaluso presented the case as follows: The property is a multifamily unit that caught fire about a year ago. The property is currently under renovation. There was a case open on this property before the fire occurred and a new case has been opened due to the trash and debris throughout property, outside of current construction area. Contractors were called to remove the trash and debris. Thirteen citations have been issued between the two cases with 11 liens filed. A payment of \$450 was made and the balance owe is \$7,921.00 including city expenses in the amount of \$746.00. Property is not in compliance.

Robert Busken appeared on behalf of Tower Place Properties and stated he has hired a property management company to maintain the property. He did not receive the most recent citations due to being out of town during January and February. Mr. Busken stated once he returned from vacation and received the notifications, he made a payment of \$450.00 toward the citation and lien fees on his property. Mr. Busken stated he has spent \$28,000 fixing the property. The property is currently under contract to be purchased and he has allowed the buyers to invest money into the property to continue repairs from the fire and additional improvements. They buyer has invested \$150,000 into the property. The property is scheduled to close on March 10, 2023. Mr. Busken requested to pay the city expense of \$746 and have the liens released to ensure the closing is able to take place on March 10.

Chairman Johnson inquired if the city expense was paid, would the city be able to release the liens. Officer Macaluso stated the issues with the property have been ongoing for years. Board Member Spille stated the first citation was issued in 2015. Board Member Spille further stated the board is unable to rule on the property while the violations remain.

Mr. Busken stated the liens being on the property will postpone the sale.

Board Member Spille inquired as to the current violations. Officer Macaluso stated the fence in the rear of the property is not in compliance and the parking lot needs to be repaved and striped. Mr. Busken stated repairs to fences and the retaining wall were made with the \$28,000 that was spent on the property. Mr. Busken stated plans for paving the parking lot were postponed due to the fire. Currently, there are construction dumpsters on the parking lot; therefore, the parking lot cannot be paved until the dumpsters are moved and construction is complete. Board Member Spille stated this case has been ongoing since 2015 and due to the property not being in compliance, the city is unable to release the liens, even if the city expense is paid.

Mr. Busken inquired if Officer Macaluso would walk the property with him after the meeting to let him know what needs to be done to bring the property into compliance. Officer Macaluso asked Mr. Busken how he plans on bringing the building that caught on fire into compliance. Mr. Busken stated the new owners plan to complete all necessary repairs after the closing takes place.

Board Member Spille reiterated that the property is required to be in compliance before a ruling can be made on the property. Board Member Spille motioned to continue the case 60 days to allow time to bring the property into compliance. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-81-OC 7660 Industrial Road Contested by: Noell Saunders City of Florence vs. Advanced Construction Services Multiple Citations

Officer Macaluso presented the case as follows: Citations issued to the property were issued in error. Officer Macaluso requested citations to be dismissed. Board Member Rowland motioned to dismiss the citations. Board Member Spille followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-23-NU 68 Vivian Drive Contested by: Chevetta Fitch City of Florence vs. Samuel Clemons Citation # 22-2215-1

Officer Macaluso presented the case as follows: Officer Carpenter inspected the property on 11/22/22 and observed trash and debris throughout property and a fence in disrepair, courtesy notice sent. Follow up inspection completed on 1/30/23 the fence was moved to surround debris in the yard, issued first citation. Property is currently not in compliance.

Chevetta Fitch appeared and stated she inherited the house from her parents and has been trying to repair the house. The items in the yard are not trash. They are items that were removed from a shed on the property. The items include two snow blowers, a welding tank, and other odds and ends. Ms. Fitch moved the fence to surround the items so that the items are out of sight. Ms. Fitch received a quote for a privacy fence and the fence will be installed at a later date.

Chairman Johnson informed Ms. Chevetta the items cannot be laying around the yard. The items need to be stored inside a building.

Board Member Spille motioned to continue the case to the April meeting. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-789-OC 7525 Industrial Road Contested by: Jeffrey G. Schoborg City of Florence vs. My Guy Auto Repair Multiple Citations

Officer Macaluso presented the case as follows: 10/14/22 received notification from the Finance Department that the occupational license is not in compliance, courtesy notice sent. First citation was issued on 12/12/22, second citation issued on 12/29/22, and the third citation was issued on 2/2/23. Occupational license is currently in compliance.

Jeffrey G. Schoborg appeared on behalf of My Guy Auto Repair.

Board Member Spille motioned to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-363-NU/SW 7800-7932 Connector Drive Contested by: Colleen Gaitan

City of Florence vs. BRE Retail Residual Owner I LLC Multiple Citations

Officer Macaluso presented his case as follows: Received a phone call on 9/27/22 that an individual was selling repackaged meat out of an unrefrigerated panel truck. An inspection was completed and the allegation received on the phone call was confirmed. Officer Macaluso issued an immediate citation due to the health and safety concerns. Individual was informed citations would be issued daily until the business vacated the property. Two citations were issued in total. Officer Macaluso spoke with the property owner who apologized and informed Officer Macaluso the individuals were not supposed to be there and that he would have them removed from the property. The individuals were removed the second day. Case is in compliance.

Officer Deno presented his case as follows: Inspection was completed on 3/31/22, observed water course debris; trash and debris; high weeds; and landscaping issues, courtesy notice was sent. Received call from property manager, Scott McFall, and vegetation was cleaned up. Mr. McFall left company and Officer Deno spoke with the new property manager, Missy Duncan. She did not bring the property into compliance and the first citation was issued on 10/14/22. The second citation was issued on 10/27/22. Missy Duncan left the company and the current property manager is Fred Spille. Officer Deno received no response from Mr. Spille and three additional citations were issued with the final citation being issued on 1/5/23.

Officer Deno spoke with the current property manager, Colleen Gaitan. Officer Deno met with Ms. Gaitan on site to review the violations. The property was brought into complete compliance within 30 days. A total of six citations were issued to the property in the amount of \$2,350.00. Two liens were filed with a city expense of \$92.00. The total balance is \$2,442.00.

Board Member Spille motioned to dismiss the citations but uphold the city expense in the amount of \$92.00. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-238-OC 7851 Tanners Lane Contested by: Greg Gilliam City of Florence vs. Greg's Affordable Car Repair Multiple Citations

Officer Macaluso presented the case as follows: 2/9/22 received notification from the Finance Department that the occupational license was not in compliance. First citation was issued on 10/31/22 with a total of six citations being issued with the last citation being issued on 2/7/23. Occupational license is not in compliance.

Greg Gilliam appeared on behalf of Greg's Affordable Car Repair. Mr. Gilliam stated he was having issues with his accountant. He sent all notices to his accountant. The accountant did not file the proper paperwork. Mr. Gilliam requested 60 days to bring the occupational license into compliance.

Board Member Spille motioned to continue the case 60 days. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**
