

# Florence City Council Business Meeting Tuesday, April 11, 2023 6:00 p.m.

## **MINUTES**

The City Council of the City of Florence, Kentucky, met in regular session on Tuesday, April 11, 2023, at 6:00 p.m. at the Florence Government Center, 8100 Ewing Boulevard, Florence, Kentucky, with Mayor Julie M. Aubuchon presiding as chair.

## **CALL TO ORDER & WELCOME:**

Mayor Julie M. Aubuchon called the regular meeting to order and declared the regular session open for the presentation of all city business.

# **INVOCATION & PLEDGE OF ALLEGIANCE:**

Mayor Aubuchon and Members of City Council recited the invocation.

## **APPROVAL OF MINUTES:**

Mayor Aubuchon called for a motion to approve the minutes of the March 28, 2023, business meeting. Councilmember Wingo motioned to approve the minutes with a second from Councilmember Carroll. **All councilmembers present voted aye.** 

# **OATH OF OFFICE:**

Chief Grau introduced the newest member of the Florence Police Department, Tanner Pinkston. Chief Grau stated Tanner is twenty-five years old and currently resides in Florence. He is a 2015 graduate of Boyle County High School and grew up in Junction City, Kentucky. After graduating high school, Tanner enlisted in the Kentucky National Guard and served for seven years until 2022. Tanner left the National Guard to pursue a career in law enforcement and worked at the Marion County Detention Center before moving to the Northern Kentucky area. Tanner briefly worked for the Grant County Detention Center before being hired by the Lexington Police Department. Chief Grau stated the department is excited to be adding Tanner.

Mayor Aubuchon administered the oath of office and welcomed Tanner to the City of Florence.

#### **PROCLAMATION:**

Mayor Aubuchon issued a Proclamation recognizing April 9, 2023 through April 15, 2023 as National Public Safety Telecommnicators Week and read the following Proclamation into record:

WHEREAS, the City of Florence recognizes that our health, safety, and well-being are often dependent on the commitment and steadfast devotion of our Public Safety Telecommunicators at the Boone County Public Safety Communications Center (PSCC); and,

WHEREAS, emergencies can occur at any time that require police, fire, emergency medical services, or other critical services; and

WHEREAS, the safety of our police officers, fire services and emergency medical services are dependent upon the quality and accuracy of information obtained from citizens who access the Boone County Public Safety Communications Center (PSCC) 911 emergency systems; and,

WHEREAS, Public Safety Telecommunicators are the first and most critical contact our citizens have with emergency services. These dedicated men and women are the First Responders and are more than anonymous voices on the telephone line; and

WHEREAS, Emergency responders rely on the knowledge and professionalism of Public Safety Telecommunicators to make critical decisions, obtain information, and quickly dispatch needed aid; and,

WHEREAS, each Telecommunicator exhibits compassion, understanding, and professionalism during the performance of their job assisting those in need.

NOW, THEREFORE, I, Julie M. Aubuchon, Mayor of the City of Florence, Kentucky, do hereby proclaim the week of April 9 through 15, 2023, to be National Public Safety Telecommunicators Week in the City of Florence, in honor of the men and women whose diligence and professionalism keep our city and citizens safe.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the City of Florence, Kentucky, to be affixed hereto, this 11th day of April, 2023.

Mayor Aubuchon introduced Sherri Knipper, Director of the Boone County Public Safety Communications Center (PSCC). Mayor Aubuchon expressed her appreciation for the telecommunicators and stated they are the connection between our citizens and our Police and Fire/EMS Department. Mayor Aubuchon commended them for their commitment and service to the city.

Ms. Knipper thanked Mayor Aubuchon and the councilmembers for the Proclamation in recognition of the telecommunicators. She stated it was an honor and privilege to serve the citizens in the community and expressed her appreciation. Ms. Knipper stated the telecommunicators of the Boone County PSCC receive special training to have the ability to answer the calls they receive for service promptly. Last year, the center received 148,769 inbound 911 emergency and non-emergency calls for service. Ms. Knipper extended an invitation to the Mayor and councilmembers to tour the center.

Councilmember Winn inquired with regard to how many employees are staffed by the PSCC. Ms. Knipper stated forty-one can be in the center and currently they can have thirty-three with eight support staff. Ms. Knipper stated they are always looking for people that love to serve their community and are currently accepting applications.

Councilmember Carroll thanked them for all the work they do for the community.

Councilmember Wingo expressed her appreciation and thanked them for all they do.

#### FIRST READING ORDINANCE O-7-2023:

Mayor Aubuchon read Ordinance O-7-2023 and called upon Joshua J. Hunt, Business and Community Development Director, with regard to discussion and possible action of Ordinance O-7-2023.

Mr. Hunt referred to his PowerPoint presentation and identified the proposed project located at 7841 Mall Road. He stated the site is the former Hollywood Video at the corner of Cayton and Mall Road. The project consists of two requests. The first request is to remove parking spots in front of the building and extend the sidewalk, adding parking spaces to the parking area closer to Mall Road. The second request was to permit additional signage. Mr. Hunt referenced his presentation and identified the proposed parking area and signage. He explained the building will become a two tenant building with AT&T and LensCrafters. Mr. Hunt introduced the owner of the building, Jerry Atkins, in the audience. Mr. Hunt explained Mr. Atkins also owns the adjacent property and commended Mr. Atkins and expressed his appreciation of the capital investment in the building.

Mayor Aubuchon read Ordinance O-7-2023. An Ordinance Adopting and Approving a Concept Development Plan and Zoning Map Amendment for a Special Sign District in a Commercial Two/Planned Development/Mall Road Overlay (C-2/PD/MR) Zone for an approximate 0.99 acre

site located at 7841 Mall Road, Florence, Kentucky, to allow redevelopment of the site, utilizing a portion of the Right-Of-Way of Mall Road, and to establish a Special Sign District to modify the requirements of building mounted and free standing signage. (LensCrafters)

The effect of this Ordinance is to allow a Concept Development Plan and Zoning Map Amendment for a Special Sign District in a Commercial Two/Planned Development/Mall Road Overlay (C-2/PD/MR) Zone, which would allow redevelopment of the site, utilizing a portion of the right-of-way of Mall Road, and a Special Sign District to modify the requirements of building mounted and free standing signage.

The full text of Ordinance O-7-2023, including its Exhibits, is available for examination in the office of the City Clerk of the City of Florence, Kentucky, in the Florence Government Center, 8100 Ewing Boulevard, Florence, Kentucky, during regular office hours.

Mayor Aubuchon called for a motion to approve the first reading of Ordinance O-7-2023. Councilmember Winn motioned to approve, with a second from Councilmember Osborne. **All councilmembers present voted aye.**
