

### CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, JULY 5, 2023

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, July 5, 2023 in the Community Rooms of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

### **CALL TO ORDER & ROLL CALL:**

Chairman Johnson called the meeting to order and requested a roll call. Present were the following three (3) Board members: Jim Johnson, Chairman; Lance Howard, (Vice-Chairman); and David Spille. Rick Rowland and Bill Sharp were absent. Bill Sharp was present at 10:09 a.m.

### **APPROVAL OF MINUTES:**

Chairman Johnson called for a motion to approve the minutes of the June 7, 2023 meeting of the Code Enforcement Board. Board Member Howard motioned to accept the minutes as read with a second from Board Member Spille. **Motion carried by unanimous vote.**

No vote was needed as a result of no one appearing at Code Board to contest the citation. Community Services Superintendent, Jeremy Kleier, upheld the citations due to non-compliance.

Board Member Spille motioned to dismiss the citation. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Officer Macaluso presented the case as follows: 1/27/23 received notification from the Finance Department that the occupational license was not in compliance, sent courtesy notice. First citation was issued on 5/11/23 and second citation was issued on 6/15/23. Occupational license is not in compliance.

Teresa Conder appeared on behalf of Andrew Allen Vance and stated that all documentation and checks had been mailed to the Finance Department. There was some initial confusion due to father and son having the same name. The son, Allen Vance rents the property from the father, Andrew Allen Vance, and when the courtesy notice and first citation were issued, it was believed they were being issued to Allen Vance, the son, whose occupational license is in compliance. They did not realize the courtesy notice and citation were being issued to the father, Andrew Allen Vance. Once it was discovered, all paperwork was submitted to the City of Florence.

Officer Macaluso requested clarification that 2023 renewal was submitted on behalf of Andrew Allen Vance. Ms. Conder confirmed it was mailed from her office. Officer Macaluso stated the form has not been received by the Finance Department.

Board Member Spille made a motion to continue the case to the August meeting. Board Member Howard followed with a second. **Motion carried by unanimous vote.**
