

# CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, SEPTEMBER 6, 2023

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, September 6, 2023 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

### **CALL TO ORDER & ROLL CALL:**

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board Members: Jim Johnson, Chairman; Lance Howard (Vice-Chairman); David Spille; Rick Rowland; and Bill Sharp.

Also present: Dale Wilson, Assistant City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Jacob Carpenter, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Childress, Fire Marshal; and Ki Ransdall, Police Officer.

### **APPROVAL OF MINUTES:**

Chairman Johnson called for a motion to approve the minutes of the August 2, 2023 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. Board Member Spille was absent from the August 2, 2023 meeting and abstained from the vote. The Board approved the minutes 4-0 with an abstention from Board Member Spille.

Contested by: Don Johnson

City of Florence vs. Cutler Real Estate Citation # 22-1249 (1-7)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Case was opened on 7/22/22, seven citations were issued for a total of \$1,700.00. No city expense was incurred. Occupational license is now in compliance.

Don Johnson appeared on behalf of Cutler Real Estate.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2021-94-OC 71 Cavalier Blvd., Suite 8 Contested by: Tony Pabst City of Florence vs. Elite Security Systems, Inc. Citation # 21-2217 (1-3)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Case was opened on 7/20/21, three citations were issued for a total of \$500.00. No city expense was incurred. Occupational license is now in compliance.

Tony Pabst appeared on behalf of Elite Security Systems Inc.

Board Member Sharp motioned to dismiss the citations. Board Member Spille followed with a second. **Motion carried by unanimous vote.** 

Contested Case # 2023-319-ZG 7544 Burlington Pike Contested by: Lee Richard Cahill City of Florence vs. Marshall Land Management, LLC Citation # 22-974-1

Officer Carpenter presented the case as follows: Citation was issued for post site plan review. Upon inspection, landscaping was not in compliance. Due to the occupancy, the property owner had six months to bring the property into compliance which would have been November 2022. During that time, an agreement was reached between the property owner, the Boone County Planning Commission and the City of Florence which would split the landscaping into five phases with the all phases being completed by October 2023. Citation was issued due to phase three and phase four not being completed on time. Phase three was due to be completed by on 6/12/23 and phase four was due to be completed by 8/9/23. Phase 5 was scheduled to be completed by 10/16/2023. Citation was issued on 8/18/23. Property is not in compliance.

Lee Richard Cahill appeared on behalf of Marshall Land Management and stated the reason the landscaping had not been completed was due to financial issues. Phase one and phase two were completed; however phase three, four, and five were not completed. Mr. Cahill stated money is still owed on phase two and the remaining landscaping that is required will cost an additional \$23,000 to complete.

Chairman Johnson requested confirmation that Mr. Cahill was requesting additional time to complete the landscaping. Mr. Cahill confirmed that they are not financially able to complete the landscaping at this time and requested a year and a half continuance based on the profit/loss statements of the company.

Board Member Rowland inquired as to the amount of landscaping that is required. Officer Carpenter stated the landscaping is required by the Boone County Planning Commission. Officer Carpenter reiterated the landscaping phasing was agreed upon by the Planning Commission, the property owner, and the City of Florence. It was further agreed upon that the phases were required to be completed on time and that the deadlines were not to be extended.

Board Member Spille stated this time of year should be their peak time for revenue. Mr. Cahill stated the fall, when the temperature drops, is their busy time of year. Mr. Cahill further stated they are in the process of making a deal with a food truck that will be parked at their location on all days they are open and the food truck will help generate revenue. Mr. Cahill stated it is difficult to receive a commitment from a food truck to stay parked at their facility at all times due to the nature of food trucks.

Mr. Cahill stated the trees are meant to be a buffer yard to form a border between the business and the residential area. Mr. Cahill stated the phase four and phase five are obsolete due to the landscaping being inside the privacy fence of the property. Board Member Spille stated the landscaping is to block sound transferring into the residential neighborhood.

Chairman Johnson inquired if the board is able to extend the deadlines due to the agreement reached between the Boone County Planning Commission, the property owner, and the City of Florence.

Assistant City Attorney Wilson stated the code board has the authority to extend the deadline.

Board Member Rowland made a motion to continue the case six months. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Officer Macaluso presented the case as follows: Officer Macaluso stated that work is being completed and most, if not all, deadlines listed on the Code Violation Resolution Agreement are being met on the first building. The deadline for all repairs on the second building is not until February, 2024. Officer Macaluso requested the case be continued to the March meeting to allow the property owners time to complete all items on the agreement.

Board Member Spille inquired if the second building Officer Macaluso was referencing was the one that caught on fire. Officer Macaluso confirmed that was the building he was referencing.

### **OTHER BUSINESS:**

Officer Macaluso requested that Burr Travis III, 37 Goodridge Drive, be served a subpoena due to numerous violations. Motion to issue a subpoena was made by Board Member Spille with a second by Board Member Sharp. **Motion carried by unanimous vote.** 

Community Services Superintendent Kleier requested to reopen Foreclosure Case No. 002-2022, Willard & Shirley McClintock, 10 Kennedy Court. Board Member Spille made a motion to reopen the case. Board Member Sharp followed with a second. **Motion carried by unanimous vote.** 

Community Services Superintendent Kleier stated the property owners have brought the property into compliance. Property owners owe \$25,400 in citation fees; \$1,601 in city expenses and lien fees; and \$3,500 in attorney fees which totals \$30,501. Attorney for the property owners proposed a settlement of \$4,000 be paid to the city. Community Services Superintendent Kleier stated this amount would not cover the city expense and the attorney fees accumulated in this case.

Discussion was held regarding a settlement amount. Community Services Superintendent Kleier proposed the city enter into an agreement with the property owners to settle in the amount of \$15,101 which would cover all city expenses, attorney fees, and \$10,000 of the citation fees due to the length of time of the case. Community Services Superintendent Kleier further proposed a clause in the agreement stating that if payments were not made on time, the entire amount would be owed.

Board Member Spille made a motion to enter into an agreement with the property owners following Community Services Superintendent Kleier proposals of a settlement agreement amount of \$15,101 and an agreement that if payments were not made in a timely manner, the total amount would be owed. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Assistant City Attorney Wilson advised no new developments on any litigation to report.
