

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, DECEMBER 6, 2023

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, December 6, 2023 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

Chairman Johnson called the meeting to order and requested a roll call. Present were the following five (5) Board Members: Jim Johnson, Chairman; Lance Howard (Vice-Chairman); David Spille; Rick Rowland; and Bill Sharp.

Also present: Thomas Nienaber, City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Jacob Carpenter, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Corpus, Code Enforcement Officer; Jeremiah Rice, Code Enforcement Officer; Randy Childress, Fire Marshal; Ki Ransdall, Police Officer; and Kevin Duncan, Police Officer.

In the audience: Vic Sabino, contested case; Dan Gamel, contested case; Billy Jewell; contested case; Bernardo De La Cruz, contested case; Angie Kuhl, contested case; William Hamilton, contested case; Ricky Narsinghani; contested case; Jenny Rice, contested case; and Daniel Strickland, continued case.

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the November 1, 2023 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. Board Member Spille was absent from the November 1, 2023 meeting and abstained from the vote. The Board approved the minutes 4-0 with an abstention from Board Member Spille.

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (11):

Contested Case # 2023-333-OC 6418 Dixie Highway Contested by: Vic Sabino

City of Florence vs. Deer Park Roofing Citation # 23-313 (1-4)

Officer Macaluso presented the case as follows: Case was for an occupational license violation Case was opened on 2/7/23, four citations were issued for a total of \$800.00. No city expense was incurred. The occupational license is not in compliance.

Vic Sabino appeared on behalf of Deer Park Roofing and stated the company switched accounting firms and there was miscommunication with the new accountant. Mr. Sabino was informed by the accounting firm that everything was in compliance. Mr. Sabino stated he would make sure everything was taken care of today.

Board Member Howard made a motion to continue the case to the January meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-353-OC 7474 Industrial Road Contested by: Sarah Nenoff City of Florence vs. Richard Fleg Citation # 23-288 (1-7)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Their headquarters is in Michigan, therefore; Officer Macaluso was speaking on their behalf. There was confusion regarding the citations, Maaco, the tenant, believed the citations were for their occupational license. However, the citations were issued to the

property owner. The property owner has brought their occupational license into compliance. Seven citations were issued for a total of \$1,700.00 with a city expense of \$92.00. Property owner has paid the city expense in the amount of \$92.00. Officer Macaluso requested the citation amount of \$1,700 be dismissed.

Board Member Spille made a motion to dismiss the citations and uphold the city expense in the amount of \$92.00. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-423-ZG 8300 Tamarack Drive Contested by: Dan Gamel City of Florence vs. DCMT Properties, LLC Citation # 23-1856-1

Officer Rice presented the case as follows: Inspection completed on 10/24/23 observed vehicle on grass and trailer being stored on property, courtesy notice issued. Follow up inspection completed on 11/1/23, no change, issued first citation. Property is currently in compliance. One citation was issued in the amount of \$100. No city expense was incurred.

Dan Gamel appeared on behalf of DCMT Properties, LLC.

Board Member Spille made a motion to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-429-ZG 2335 Antoinette Way City of Florence vs. Renee Steffen Citation # 23-1138-1

Officer Carpenter presented the case as follows: No one appeared on behalf of Renee Steffen. The property is in compliance and the citation was paid. Case has been closed.

Contested Case # 2023-357-ZG/OL 151 Roger Lane City of Florence vs. Billy Jewell Citation # 23-1383 (1-2)

Officer Macaluso presented the case as follows: Received a complaint regarding commercial vehicles being stored at the property. 7/19 inspection completed, observed commercial truck and commercial mowers being stored on the property, courtesy notice sent. Two citations were issued for a total of \$800.00. The truck remains on the property and no occupational license.

Billy Jewell appeared and stated the occupational license had been paid. Mr. Jewell stated the commercial items have been stored in the garage; however, the truck was his personal vehicle. Mr. Jewell offered to remove the commercial signs from hthe truck.

Officer Macaluso requested a copy of the occupational license. Mr. Jewell provided a copy of the occupational license. Officer Macaluso stated the occupational license was listed differently than what was being searched. Officer Macaluso requested a continuance to confirm the occupational license.

Officer Macaluso stated if the advertisements were removed from the truck, the vehicle would be in compliance. Additionally, the trailer would need to be stored in the garage.

Board Member Howard made a motion to continue the case to the January meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-345-ZG/OL/PM 6603 Dixie Highway

City of Florence vs. Bernardo De La Cruz Citation # 23-1586 (1-6)

Officer Macaluso presented the case as follows: Received multiple complaints regarding occupational license violation, temporary structure being erected in rear of property, roof and drainage in disrepair, exterior walls in disrepair, construction was being completed with no permit, and unlicensed vehicles on property. Six citations have been issued in the amount of \$7,050.00. No city expense was incurred. Officer Macaluso stated the majority of the violations were regarding the temporary structure and repairs being completed with no permit. He stated the city is reviewing the plans that were submitted for the structure being built; however, the plans have not been approved at this time. Officer Macaluso stated the property has an occupational license for the granite business; however, observed multiple vehicles

being displayed for sale on the property and received complaints that vehicles were being repaired in the rear of the property. Officer Macaluso observed multiple vehicles on the property in different stages of disrepair. There is no way to prove the vehicles are being repaired at the property; however, with the vehicles being in disrepair, that is still a violation. Therefore, the property is not in compliance.

Bernardo De La Cruz appeared before the board.

Board Member Spille inquired if the temporary structure was built without any permits.

Officer Macaluso stated the building was partially removed.

Board Member Spille inquired if there were any permits or inspections completed on the construction.

Office Macaluso confirmed there were no permits or inspections. The building department issued a stop work order.

Mr. De La Cruz stated the citation was issued due to the roof needing repairs. When the repairs were being completed, they were forced to stop due to not having a permit for the construction which was being completed. Mr. De La Cruz applied for the permit and was informed that he would need plans for the construction. The plans have been submitted for approval. Mr. De La Cruz stated the vehicles that were for sale on the property were his personal vehicles that were being sold. Mr. De La Cruz stated he had not replaced the walls on the building. Officer Macaluso stated a wall was missing. Mr. De La Cruz stated a piece of plywood had to be replaced on the wall.

Officer Macaluso stated downspouts are missing. Mr. De La Cruz stated the downspouts were removed due to the work being completed on the roof. The rafters were being replaced when the Boone County Building Department made them cease work.

Chairman Johnson inquired as to when the work order was issued.

Officer Macaluso stated he was contacted by the Building Department on 8/21/23 regarding the stop work order on the property.

Mr. De La Cruz stated he applied for the permit and was informed by the Building Department that he would need to bring his property into compliance with the City of Florence before they would issue the permit.

Chairman Johnson inquired if the occupational license was in compliance.

Officer Macaluso stated the occupational license for the granite business was not current. The citation was issued for the auto sales business which was on the property.

Mr. De La Cruz denied there was an auto sale business on the property and stated cars being sold were his personal vehicles.

Officer Macaluso stated vehicles are not permitted to be sold on commercial property without an occupational license.

Board Member Spille inquired regarding the recreation hall. Officer Macaluso stated that the recreation hall had been resolved. Fire Marshal Childress stated fire inspections need to be completed on 6603 Dixie Highway and 6605 Dixie Highway.

Mr. De La Cruz stated he does not own 6605 Dixie Highway.

Fire Marshal Childress stated a fire inspection needs to be completed on 6603 Dixie Highway.

Mr. De La Cruz stated that someone recently completed a fire inspection.

Fire Marshal Childress stated he has no record of an inspection.

Mr. De La Cruz requested clarification of what repairs need to be completed to bring the property into compliance.

Officer Macaluso stated a courtesy notice was sent explaining the violations.

Mr. De La Cruz stated he was informed by the Boone County Planning Commission that he would not be able to obtain the permit until the code violations were brought into compliance. Board Member Spille informed Mr. De La Cruz that the property would not be in compliance until the permit was obtained. Officer Macaluso stated he would follow up with the Boone County Planning Commission for clarification and relay the information to Mr. De La Cruz.

Fire Marshal Childress offered to meet with Mr. De La Cruz on the property to let him know what needed to be completed to bring the property into compliance.

Board Member Spille made a motion to continue the case to the January meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-357-OC 7290 Turfway Road Contested by: Angie Kuhl City of Florence vs. KT & J Inc. dba Flowerama Citation # 23-302 (1-3)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Case was opened on 2/7/23, three citations were issued for a total of \$500.00. No city expense was incurred. One payment was made in the amount of \$50.00. A total of \$450.00 is currently owed. Occupational license is now in compliance.

Angie Kuhl appeared on behalf of KT & J dba Flowerama. Ms. Kuhl stated this issue has been ongoing for several months. Ms. Kuhl asked what the reason for the citation was when Officer Macaluso delivered the citation to the business. Officer Macalso informed Ms. Kuhl that she would need to call the Finance Department. Ms. Kuhl contacted the Finance Department and was informed she would need to speak with the Code Enforcement Officer. Ms. Kuhl was able to find out that the payment was being processed by the lock box company; however, the company was not processing the paperwork submitted with the payment.

Officer Macaluso stated that when there is an occupational license violation, he does not receive specific information from the Finance Department as to what the violation is due to sensitive personal information on the occupational license paperwork. He only receives confirmation that the occupational license is not in compliance.

Ms. Kuhl stated many phone calls were made to the city with no response. Ms. Kuhl was able to contact the City Clerk, Melissa Kramer and was able to have the issue straightened out.

Board Member Spille made a motion to dismiss the citations. Board Member Rowland followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2023-522-OC 107 Raintree Road Contested by: William Hamilton City of Florence vs. Hamilton Properties Citation # 23-176 (1-4)

Officer Macaluso presented the case as follows: Case was for an occupational license. Three citations were issued for a total of \$800.00. Three liens were filed with a city expense of \$138.00. Mr. Hamilton did not receive the mail sent by the city. Officer Macaluso confirmed the mailing address was incorrect on the PVA website. Officer Macaluso stated the occupational license is currently in compliance and requested the citations be dismissed and the city expense be upheld.

William Hamilton appeared on behalf of Hamilton Properties.

Board Member Howard made a motion to dismiss the citations but uphold the city expense in the amount of \$138.00. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-480-OC 5905 Merchants Street Contested by: Ricky Narsinghani City of Florence vs. Seva Hospitality Division 1 Citation # 23-166 (1-5)

Officer Macaluso presented the case as follows: Case was for an occupational license. Case was opened on 5/23, five citations were issued for a total of \$1,100.00. No city expense incurred. Occupational license is not in compliance. Payroll issues still exist. Officer Macaluso requested the case be continued to the January meeting.

Ricky Narsinghani appeared on behalf of Seva Hospitality Division 1.

Board Member Howard made a motion to continue the case to the January meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-914-OC 5905 Merchants Street Contested by: Ricky Narsinghani

City of Florence vs. Seva at Houston Lakes, LLC Citation # 23-1045 (1-2)

Officer Macaluso presented the case as follows: Case is for an occupational license. Case was opened on 5/23, two citations were issued for a total of \$200.00. No city expense incurred. Occupational license is not in compliance. Payroll issues still exist. Officer Macaluso requested the case be continued to the January meeting.

Ricky Narsinghani appeared on behalf of Seva at Houston Lakes, LLC

Board Member Howard made a motion to continue the case to the January meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-438-NU/ZG 320 Center Street

City of Florence vs. Jenny Rice Citation # 23-1915 (1-2)

Officer Corpus presented the case as follows: Inspection completed on 11/2/23, observed trash and debris; trailer stored on property; and commercial vehicle stored on property. Two citations were issued in the amount \$300.00. No city expense incurred. Property is currently in compliance.

Jenny Rice appeared before the board and stated her son will not leave her property and is the cause of the citations. Ms. Rice requested advice on how to evict her son. Officer Macaluso advised Ms. Rice to have her son trespassed. Officer Duncan offered to assist Ms. Rice following the meeting.

Board Member Spille made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**
