

# CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, JANUARY 3, 2024

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, January 3, 2024 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

### **CALL TO ORDER & ROLL CALL:**

Chairman Johnson called the meeting to order and requested a roll call. Present were the following four (4) Board Members: Jim Johnson, Chairman; Lance Howard (Vice-Chairman); David Spille; and Bill Sharp. Board Member Rick Rowland was absent.

Also present: Thomas Nienaber, City Attorney; Brandi Roundtree, Assistant City Clerk; Jeremy Kleier, Community Services Superintendent; Jacob Carpenter, Code Enforcement Officer; Mike Macaluso, Code Enforcement Officer; Randy Corpus, Code Enforcement Officer; Jeremiah Rice, Code Enforcement Officer; Randy Childress, Fire Marshal; and Ki Ransdall, Police Officer.

In the audience: Mark Bengel, subpoenaed case; Heather McClain, contested case; Tara Prunhagen, contested case; Randy Adkins, contested case; Eric Fegan, contested case; Michael Brokamp, continued case; Donna Linville, continued case; and Bernardo De La Cruz, continued case.

### **APPROVAL OF MINUTES:**

Chairman Johnson called for a motion to approve the minutes of the December 6, 2023 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.** 

#### **SWEARING IN:**

The Code Enforcement Officers were sworn in by Chairman Johnson.

#### **SUBPOENAED CASES (1):**

Subpoenaed Case # 2021-8-OC 8071 Connector Drive

City of Florence vs. JL Bayridge dba Red Wing Shoe Citation # 21-616 (1-15)

Officer Macaluso presented the case as follows: Case was for an occupational license violation and opened on 1/29/21, sixteen citations were issued for a total of \$4,400. No city expenses incurred. Mr. Bengel submitted one check for the code enforcement fines and another check for the occupational license fees. Officer Macaluso stated the finance department was still processing the payments which would likely result in a shortage of the occupational license fees. Therefore, the occupational license was not in compliance.

Mark Bengal President of JL Bayridge dba Red Wing Shoe appeared before the board. Mr. Bengal stated approximately 70% of the occupational license and citation fees were paid. Mr. Bengal stated he was working with Ashley in the finance department to ensure all required documentation was provided. Mr. Bengal requested additional time to bring the occupational license into compliance.

Chairman Johnson inquired as to why it took so long to start working on the occupational license. Mr. Bengal stated there was some confusion between him and his bookkeeper as to who was filing the paperwork

Board Member Spille motioned to continue the case to the February meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-490-ZG 7761 Anchor Way City of Florence vs. Jordan Reed Citation # 23-1962-1

Officer Carpenter presented the case as follows: Inspection completed on 11/9/23, observed basketball goal in right-of-way, courtesy notice issued. Follow up inspection completed on 11/28/23, no change, issued first citation. Property is currently in compliance. One citation was issued in the amount of \$50.00. No city expense was incurred. Officer Carpenter received notification that Mr. Reed was unable to attend the meeting and requested the citation be dismissed on his behalf.

Board Member Howard motioned to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.** 

Contested Case # 2023-501-ZG 106 Center Park Drive City of Florence vs. John Coulter Citation # 23-2045-1

Officer Corpus presented the case as follows: Inspection completed on 11/21/23, observed trailer being stored in driveway, courtesy notice issued. Follow up inspection completed on 12/1, no change, issued first citation. Property is currently in compliance. One citation was issued in the amount of \$50.00. No city expense was incurred. Officer Corpus received notification that Mr. Coulter was unable to attend the meeting.

Officer Corpus stated the trailer being stored in the driveway had been a reoccurring issue at this property.

Board Member Spille motioned to uphold the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Officer Rice presented the case as follows: Inspection completed on 11/21/23, observed trash and debris and high weeds and grass throughout property, courtesy notice issued. Follow up inspection completed on 11/29/23, no change, issued first citation. Property is currently in compliance. One citation was issued in the amount of \$50.00. No city expense was incurred.

Heather McClain appeared before the board.

Board Member Howard motioned to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.** 

Contested Case # 2022-831-OC 71-75 Cavalier Blvd. Contested by: Tara Prunhagen

City of Florence vs. United Steel Workers Citation # 22-1239 (1-7)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Case was opened on 7/21/22, seven citations were issued for a total of \$1,700.00. No city expense was incurred. One payment in the amount

of \$300.00 was submitted. A total of \$1,400.00 is currently owed. Occupational license is not in compliance. Officer Macaluso stated the 2021, 2022, and 2023 renewals had not been submitted.

Tara Prunhagen appeared on behalf of United Steel Workers and stated the financial officers were not completing their duties and she was unaware until notices were received from the IRS. The financial officers resigned, and she hired an accountant to help resolve all issues. Ms. Prunhagen explained her difficulties and requested additional time to bring the occupational license into compliance.

Board Member Howard motioned to continue the case to the February meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Officer Corpus presented the case as follows: Inspection completed 11/8/23, observed Spectrum wire box in disrepair, courtesy notice sent. Follow up inspection completed 11/27/23, no change, issued first citation. Property is currently in compliance. One citation was issued in the amount of \$50.00. No city expense was incurred.

Randy Adkins appeared on behalf of Village of South Fork Creek.

Board Member Spille motioned to dismiss the citation. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Follow up inspection completed on 11/20, no change, first citation was issued. Six additional citations were issued for a total of \$650.00. One payment in the amount of \$150.00 was submitted. A total of \$500.00 is currently owed. Property is currently in compliance.

Eric Fegan appeared on behalf of Florence Center Partners LLC.

Board Member Sharp motioned to dismiss the citations. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Officer Corpus presented the case as follows: City crew observed grease being dumped into the sewer drain and notified Officer Corpus. First citation was issued due to the harmful nature of the violation on 12/7/23. Four citations were issued for a total of \$800.00. One payment in the amount of \$50.00 was submitted. A total of \$750.00 is currently owed. Officer Corpus stated a representative from the EPA also completed an inspection and a report was being issued but had not yet been received by the city.

Eric Fegan appeared on behalf of Union 20 LLC. Mr. Fegan stated he had been out of the country and was just notified of this issue. The tenant is correcting the issue and will be paying all fines. Mr. Fegan requested additional time to ensure the property is brought into compliance.

Board Member Spille motioned to continue the case to the February meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**
