

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, FEBRUARY 7, 2024

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, February 7, 2024 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the January 3, 2024 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.**

SWEARING IN:

The Code Enforcement Officers were sworn in by Chairman Johnson.

CONTESTED CASES (8):

Contested Case # 2023-149-OC 60 Cavalier Blvd.

City of Florence vs. Ciara Cassity Citation # 21-2614 (1-2)

Officer Rice presented the case on behalf of Officer Macaluso as follows: Case was for an occupational license violation. Case was opened on 9/15/21, two citations were issued for a total of \$200.00. No city expense was incurred. Occupational License is now in compliance.

Ciara Cassity appeared before the board.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2023-135-OC 60 Cavalier Blvd.
Contested by:

City of Florence vs. Brigid Decker Citation # 21-2628 (1-2)

Officer Rice presented the case on behalf of Officer Macaluso as follows: Case was for an occupational license violation. Case was opened on 9/16/21, two citations were issued for a total of \$200.00. No city expense was incurred. One payment was made in the amount of \$50.00. A total of \$150.00 is currently owed. Occupational License is now in compliance.

Brigid Decker appeared before the board.

Board Member Sharp made a motion to dismiss the citations. Board Member Howard followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2023-722-OC 1336 Hansel Ave. Contested by: Tom Howard City of Florence vs. ARG TCFLOKY001 LLC Citation # 23-160 (1-5)

Officer Rice presented the case on behalf of Officer Macaluso as follows: Mr. Howard did not appear and the occupational license is not in compliance. Five citations were issued for a total of \$1,100.00 with a city expense of \$92.00. A total of \$1,192.00 is currently owed. Officer Macaluso had reached out to Mr. Howard and received no contact. Officer Rice stated he received an email from Melissa Kramer, City Clerk, regarding this case.

Board Member Howard made a motion to uphold the citations. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2023-542-ZG 41 Lake Drive City of Florence vs. Joseph Vaughn Citation # 23-2088 (1-3)

Code Enforcement Officer Corpus is responsible for overseeing this case: Board Member Rowland stated he had information regarding the case. Board Member Rowland stated the property is in compliance and the property owner was going to contest, but he informed her he would let the board know they were in compliance and request the citations be dismissed.

Board Member Sharp made a motion to dismiss the citations. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2022-777-OC 6805 Houston Road Contested by: Marshall Dosker, Attorney City of Florence vs. Houston Shoppes- One, LLC Citation # 22-2072 (1-11)

Officer Rice presented the case on behalf of Officer Macaluso as follows: Case was for an occupational license. Case was opened on 10/18/22, eleven citations have been issued for a total of \$2,900.00 with a city expense of \$322.00. One payment was made in the amount of \$50.00. A total of \$3,172.00 is currently owed. Occupational license is not in compliance.

Attorney Marshall Dosker appeared on behalf of Houston Shoppes-One, LLC and stated he was under the impression that the occupational license was in compliance. Attorney Dosker stated he came to the government center and filed all the paperwork and paid the taxes and penalty and interest himself. Attorney Dosker stated the owner is older and was unsure of the requirements regarding obtaining an occupational license which caused miscommunication and confusion.

Officer Rice stated he was informed by the Finance Department that the occupational license was not in compliance.

Chairman Johnson informed Attorney Dosker that the city expense will not be dismissed even if the citations are dismissed.

Board Member Spille made a motion to continue the case to the March meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-46-ZG 241 Main Street Contested by: Joseph Kennedy City of Florence vs. Samuel Craig Properties, LLC Citation # 23-2394-1

Officer Corpus presented the case as follows: Mr. Kennedy was not able to appear due to medical issues. Officer Corpus stated the property is in compliance with the disabled vehicle and not in compliance with the trash and debris. Officer Corpus requested a continuance to the March meeting.

Board Member Rowland made a motion to continue the case to the March meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-146-OC 7210 Turfway Road

City of Florence vs. Kailey Brown Citation # 23-2244-1

Officer Rice presented the case as follows: Case was for an occupational license violation. She is a realtor with Keller Williams. Citation was issued when Ms. Brown was already in the process of receiving her occupational license.

Board Member Sharp made a motion to dismiss the citation. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-67-NU/PM 8593 Winthrop Circle Contested by: Glenn & April Curry City of Florence vs. Glenn & April Curry Citation # 23-2258 (1-2)

Officer Carpenter presented the case as follows: Inspection completed on 12/14/23 observed garage door in disrepair and trash and debris throughout the property, courtesy notice issued. Two citations were issued for a total of \$400.00. One payment was made in the amount of \$100.00. A total of \$300.00 is currently owed. The garage door has been repaired; however, the trash and debris remain. The property is not in compliance.

Glenn and April Curry appeared before the board and stated their disabled son resides at this property and they were unaware of the citations. Mr. Curry stated once they became aware of the issues the garage door was repaired. Mr. Curry stated they will ensure the trash and debris is removed.

Board Member Spille made a motion to continue the case to the March meeting. Board Member Howard followed with a second. **Motion carried by unanimous vote.**
