

CODE ENFORCEMENT BOARD MINUTES: WEDNESDAY, APRIL 3, 2024

The City of Florence, Kentucky Code Enforcement Board met at 10:00 a.m. on Wednesday, April 3, 2024 in the Council Chamber of the Florence Government Center with Code Enforcement Board Chairman, Jim Johnson presiding.

CALL TO ORDER & ROLL CALL:

APPROVAL OF MINUTES:

Chairman Johnson called for a motion to approve the minutes of the March 6, 2024 meeting of the Code Enforcement Board. Board Member Sharp motioned to accept the minutes as read with a second from Board Member Howard. **Motion carried by unanimous vote.**

The Code Enforcement Officers were sworn in by Chairman Johnson.

SUBPOENAED CASES (2)

Subpoenaed Case # 2023-379-PM/ZG/NU 66 Utz Drive

City of Florence vs. Mark, Patricia & John Shackleford Citation # 23-1638 (1-17)

Officer Macaluso presented the case as follows: Officer Macaluso received notification the attorney for the Shackleford's was unable to attend and they requested the case be continued to the May meeting. Officer Macaluso requested the case be continued to the May meeting.

Board Member Spille made a motion to continue the case to the May meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-84-NU/PM/ZG 109 Lee Street City of Florence vs. Charles & Rachel Ritter Multiple Citations

Officer Carpenter presented the case as follows: Officer Carpenter stated there were multiple cases on this property. Case # 24-529 was opened on 3/15/24 for an unlicensed/disabled vehicle on the property, first citation was issued. The vehicle was removed, and the case is in compliance.

Board Member Howard made a motion to dismiss Citation # 24-529-1. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Officer Carpenter stated Case #23-440 was opened on 3/2/23 by Officer Deno for trash and debris throughout property; zoning permit required; roof was in disrepair; and the fence was in disrepair. All violations have been brought into compliance. Sixteen citations were issued for a total of \$11,800.00 with a city expense of \$782.00. A total of \$12,582.00 is currently owed.

Charles and Rachel Ritter appeared before the board. Board Member Spille inquired as to why it took so long to bring the property into compliance. Mrs. Ritter stated one thing would get fixed and another thing would break, and it just took time to complete all necessary repairs.

Board Member Spille made a motion to dismiss the citations for case # 23-440 but uphold the city expense of \$782.00. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Officer Corpus presented the case as follows: Officer Corpus stated Mr. Wessels was unable to attend the meeting and requested the case be continued to the May Meeting.

Board Member Rowland made a motion to continue the case to the May meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

City of Florence vs. Sevad Dizadrevic Multiple Citations

Officer Rice presented the case as follows: Case was for an occupational license violation. Eight citations were issued for a total of \$1,600.00. No city expenses were incurred. The occupational license is currently in compliance.

Nafka Dizadrevic appeared on behalf of Sevad Dizadrevic.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2024-181-OL/ZG 2201 Antoinette Way Contested by: Nafka Dizadrevic

City of Florence vs. Lions LLC Citation # 23-1984-1

Officer Macaluso presented the case as follows: Case was for an occupational license and a home occupational permit. One citation was issued in the amount of \$100.00. No city expenses were incurred. Citation has been paid. Officer Macaluso stated the occupational license and home occupational permit are now in compliance.

Nafka Dizadrevic appeared on behalf of Lions LLC.

Board Member Sharp made a motion to dismiss the citation. Board Member Spille followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2022-274-OC 60 Cavalier Blvd.

City of Florence vs. Carol Rodgers-Rivir Citation # 21-2736 (1-4)

Officer Macaluso presented the case as follows: Case was for an occupational license violation. Case was created on 4/27/22, four citations were issued for a total of \$800.00. No city expense was incurred. Occupational license is in compliance.

Carol Rodgers-Rivir appeared before the board.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2024-196-OC 7210 Turfway Road

City of Florence vs. David Jones Citation # 23-2366 (1-2)

Officer Rice presented the case as follows: Case was for an occupational license. Case was created on 12/20/23, two citations were issued for a total of \$200.00. No city expense was incurred. Officer Rice stated the occupational license is not in compliance. Officer Rice stated Mr. Jones maintained his real estate license but does not practice and believed that an occupational license was not required. Officer Rice stated Mr. Jones' profile is listed on Keller William's website as an active real estate agent; therefore, an occupational license is required. Officer Rice was informed by the finance department that Mr. Jones owed five years of back taxes.

David Jones appeared before the board and stated he does not work out of the 7210 Turfway Road office and was under the impression that the citations were being issued due to his profile being listed on the Keller Williams website. Mr. Jones stated that he maintains his real estate license; however, does not work as a real estate agent. Mr. Jones stated he had a full-time job and that he splits his time between his home in Northern Kentucky and his home on Dolphin Island.

Mr. Jones stated he had not been in the office at 7210 Turfway Road until he retrieved the letter from the city. Mr. Jones came to the Government Center and spoke with the finance department regarding the citations. Mr. Jones completed the occupational license application and paid the occupational license fee. Mr. Jones requested the city waive the penalty and interest for his taxes for the previous five years.

Officer Macaluso stated penalty and interest for the occupational license are not handled through the code enforcement board; the penalty and interest for the taxes are handled through the finance department. Officer Macaluso informed Mr. Jones that he was able to request an abatement of the penalty and interest through the finance department.

Mr. Jones stated he had only sold his own personal property. Officer Macaluso stated selling your own property does not count toward the real estate license income.

Officer Macaluso stated that Mr. Jones would need to bring his W-2s to the city to prove there was no income earned from real estate sales within the past five years. Once there was proof there were no sales, a discussion could be had as to whether an occupational license was required.

Board Member Spille made a motion to continue the case to the May meeting. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-163-OC 8860 US 42 Contested by: Carina Torres

City of Florence vs. El Palenque Inc. Citation # 23-2457 (1-2)

Officer Macaluso presented the case as follows: Case was created on 12/29/23, two citations were issued for a total amount due of \$200.00. No city expense was incurred. Occupational license is in compliance.

Carina Torres appeared on behalf of El Palenque Inc.

Board Member Sharp made a motion to dismiss the citations. Board Member Spille followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-140-OC 7210 Turfway Road

City of Florence vs. Amanda Brady Citation # 23-2238 (1-3)

Officer Rice presented the case as follows: Case was for an occupational license violation. Case was created on 12/14/23, three citations were issued in the amount of \$500.00. No city expense was incurred. Payments were made in the amount of \$200.00. A total of \$300.00 is currently owed. Occupational license is now in compliance.

Amanda Brady appeared before the board.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-161-OC 7210 Turfway Road

City of Florence vs. Bill Cooper Citation # 23-2280 (1-3)

Officer Rice presented the case as follows: Case was for an occupational license violation. Case was created on 12/15/23, three citations were issued in the amount of \$500.00. No city expense was incurred. Occupational license is now in compliance.

Bill Cooper appeared before the board.

Board Member Sharp made a motion to dismiss the citations. Board Member Spille followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-162-OC 7210 Turfway Road

City of Florence vs. Adam Craun Citation # 23-2281 (1-4)

Officer Rice presented the case as follows: Case was for an occupational license violation. Case was created on 12/15/23, four citations were issued in the amount of \$800.00. No city expense was incurred. Occupational license is now in compliance.

Adam Craun appeared before the board.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-295-OC 71-75 Cavalier Blvd.
Contested by: Nina Ajaezu

City of Florence vs. Ameribest Homecare Solutions Citation # 24-166 (1-2)

Officer Rice presented the case as follows: Case was for an occupational license violation. Case was created on 1/19/24, two citations were issued in the amount of \$200.00. No city expense was incurred. Occupational license is now in compliance.

Nina Ajaezu appeared on behalf of Ameribest Homecare Solutions.

Board Member Howard made a motion to dismiss the citations. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-531-OL/ZG 1169 Appomattox Drive Contested by: Kirk Pfefferman, Attorney

City of Florence vs. Carole Reed-Mahoney Multiple Citations

Officer Macaluso presented the case as follows: Case was created on 11/16/23, received a complaint regarding the condition of the property and a business being ran out of the property. Officer Macaluso conducted research and was able to find Jim Perry Electric registered to the address. Officer Macaluso also observed a dumpster placed in the driveway for an extended period. Five citations were issued in the amount of \$1,700.00. No city expenses were incurred.

Officer Macaluso stated he spoke with Mr. Perry at the property with Mr. Perry stating that he owned a business, but it was not active and he was at the property cleaning it out. Officer Macaluso spoke with Attorney Pfefferman as well regarding the property and the citations and what needed to be done to bring the property into compliance.

Officer Macaluso stated the dumpster and trash and debris had been removed from the property and if the business vacates the property, the occupational license would be in compliance as well.

Chairman Johnson confirmed that all violations are in compliance with the exception of the occupational license. Officer Macaluso confirmed.

Attorney Kirk Pfefferman and Shad James Perry appeared on behalf of Carole Reed-Mahoney. Attorney Pfefferman stated Mr. Perry established his LLC at that property; however, no business was ever conducted at that property. Attorney Pfefferman stated Mr. Perry's W-2s show his income from 2022 was not from the business. Attorney Pfefferman stated his business license through the state is now listed as inactive and his electrical license has been placed in escrow.

Board Member Spille made a motion to dismiss the citations. Board Member Rowland followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2023-517-OL/ZG 7349 Burlington Pike Contested by: Craig Payne City of Florence vs. Nicholas Payne Citation # 23-1572 (1-2)

Officer Macaluso presented the case as follows: Received notification that Mr. Payne was unable to attend due to working out of town and requested the case be continued to the May meeting.

Board Member Spille made a motion to continue the case to the May meeting. Board Member Howard followed with a second. **Motion carried by unanimous vote.**

Contested Case # 2024-302-ZG 8227 US 42 Contested by: Daron Skidmore City of Florence vs. David & Sandra Helmer c/o Car-X Citation # 24-522-1

Officer Rice presented the case as follows: Received a request to withdraw the case from the agenda. Officer Rice stated he tried to call Mr. Skidmore this morning with no response. Officer Rice requested the board uphold the citation.

Board Member Sharp made a motion to uphold the citation. Board Member Spille followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2024-205-PM 205 Kentaboo Ave.

City of Florence vs. Caitlin Roberts Citation # 23-2307-1

Officer Corpus presented the case as follows: Inspection was completed on 12/18/23, observed exterior walls in disrepair. One citation was issued in the amount of \$50.00. No city expense was incurred. Property is now in compliance.

Caitlin Roberts appeared before the board.

Board Member Howard made a motion to dismiss the citation. Board Member Sharp followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2024-105-OC 7210 Turfway Road

City of Florence vs. Tyler Andrew Citation # 23-2201 (1-2)

Officer Rice presented the case as follows: Case was for an occupational license violation. Case was created on 12/13/23, two citations were issued in the amount of \$200.00. No city expense was incurred. Occupational license is now in compliance.

Tyler Andrew appeared before the board.

Board Member Sharp made a motion to dismiss the citations. Board Member Howard followed with a second. **Motion** carried by unanimous vote.

Contested Case # 2024-221-PM/ZG 132 Honeysuckle Drive Contested by: Alex Edmondson, Attorney City of Florence vs. Advanced Construction Services Citation # 24-494 (1-8)

Officer Macaluso presented the case as follows: Case is for 132 Honeysuckle Drive that burned down. Officer Macaluso stated the property was before the board last month and the citations were dismissed due to technical errors on the citations.

Officer Macaluso stated citations were issued for broken windows; exterior doors in disrepair; protective treatment; roofs and drainage; unsafe premises; wheel blocks; exterior walls in disrepair; fence condition; and sidewalks/driveway in disrepair. Officer Macaluso stated eight citations have been issued in the amount of \$16,500.00 since last code meeting. No city expense was incurred.

Officer Macaluso stated the broken windows and doors were repaired; the fence was repaired; and new sidewalks were poured. Officer Macaluso stated there is some siding on the property that was getting ready to be put on the building which would repair the protective treatment; roofs and drainage; unsafe premises; and exterior wall violations. The wheel blocks are still in disrepair. Property is not in compliance.

Board Member Spille made a motion to continue the case to the May meeting. Board Member Sharp followed with a second.

Attorney Alex Edmondson; Tom Torline, owner of Advanced Construction Services; and Noell Saunders, manager of Advanced Construction Services, appeared before the board.

Attorney Edmondson stated there was an active building permit and they are currently working on internal structural issues before completing the remaining violations on the exterior of the property. There has been a great amount of progress since the previous meeting.

Attorney Edmondson stated Mr. Torline was running into the same financing issues as last month. Cinfed is Mr. Torline's lender, and they will not approve the construction loan due to citations being issued to the property. Attorney Edmondson stated all repairs completed have been paid for out of pocket; however, to progress any further, financing was required.

Attorney Edmondson requested all citations be dismissed so that financing is provided, and the repairs can be completed.

Officer Macaluso stated the property haf been an issue for a long time and a previous agreement was reached and the requirements were not met.

Board Member Spille inquired if a new agreement could be negotiated.

Attorney Nienaber confirmed and inquired as to how long repairs would take.

Attorney Edmondson stated that repairs were anticipated to be completed 4-5 months after financing is received.

Board Member Spille stated the case needs to be continued to renegotiate the contract and then the citations could be dismissed once a new agreement is in place.

Attorney Nienaber inquired was Cinfed is refusing to provide financing due to a lien being placed on the property.

Tom Torline stated there are no liens on the property and the financing was being denied due to the citations. Mr. Torline stated as soon as they took over the property, a new roof was placed on the property and repairs were completed before the sale was finalized.

Attorney Nienaber clarified that Board Member Spille was requesting the case be continued to the next meeting to allow time to renegotiate the previous agreement with the understanding that the liens/citations would be dismissed, and the owner would be given until October to bring the property into compliance.

Attorney Nienaber stated the two primary terms of the renegotiated agreement would be the citations would be dismissed and no new citations would be issued until October, 2024.

Board Member Rowland inquired as to why an agreement was needed when the citations could be dismissed and enforcement could begin again at any time without an agreement.

Board Member Spille stated there was a previous agreement in place and the requirements were not met and by negotiating a new agreement, it would ensure the property owners and the city were both held to their word.

Board Member Spille stated if an agreement was reached, the parties would not need to appear at the May meeting.

Attorney Nienaber stated the agreement should be signed by the end of next week.

Board Member Spille reiterated his motion to continue the case to the May meeting to allow the parties time to reach a new agreement. Board Member Sharp followed with a second. **Motion carried by unanimous vote.**
