### SNOW EMERGENCY FORM

EFFECTIVE \_\_\_\_\_, ON \_\_\_\_\_, \_\_\_\_\_, MAYOR OF THE CITY OF FLORENCE, KENTUCKY DECLARED A SNOW EMERGENCY TO EXIST WITHIN THE CITY OF FLORENCE, PURSUANT TO ORDINANCE O-4-2025. THE CITY CLERK SHALL CONTACT THE BOONE COUNTY PUBLIC SAFETY COMMUNICATIONS CENTER (P.S.C.C.) AND THE FOLLOWING MEDIA WITH THE SNOW EMERGENCY DECLARATION INFORMATION:

*"The City Of Florence, Has Declared A Snow Emergency, Level \_\_ And Residents Should Remove Vehicle(S) Parked On The Street To Allow Crews To More Effectively Clear Snow From The Street. This Declaration Of Snow Emergency Shall Remain In Effect Until Rescinded By The Mayor."*

#### LEVELS OF SNOW EMERGENCIES:

1. Level One: Roadways are hazardous with blowing and/or drifting snow, roadways may be icy. Motorists are advised to use caution due to hazardous road conditions resulting from these conditions and possible accumulations of snow and/or ice.
2. Level Two: Roadways are extremely hazardous due to accumulated or blowing snow, and roadways may be icy. Only essential travel is advised. Essential travel includes, but is not limited to, travel for public safety and emergency purposes, travel to and from work if required by the employer, travel for medical reasons, and travel to obtain necessary provisions such as food, medicine, or fuel.
3. Level Three: Roadways are extremely dangerous and travel is restricted to the following: public safety and emergency personnel, travel to and from work if attendance is required by the employer and travel for medical purposes or to obtain necessary provisions. Travel for any other purpose is considered to be non-essential and violations may be enforced by law enforcement personnel. Violators are subject to prosecution.
